

BMOBILE ROLLOVER MINUTES PROMOTION

OFFICIAL RULES AND REGULATIONS

1. **PROMOTION PERIOD:** Starting February 8th 2012 and ending February 28th 2012.
2. **ELIGIBILITY:** To enter and be eligible to win, you must be a legal resident of Trinidad & Tobago, be 18 years of age or older, with a bMobile Postpaid service account and handset. Persons in any of the following categories are also NOT eligible to participate or win prizes: (a) any person who, at any time on or after January 20, 2012, was or is a director, officer, employee, agent of TSTT, or any of their respective parents, subsidiaries, divisions, or affiliated companies, franchisees, or service agencies, or independent contractors; (b) individuals engaged in the development, production or distribution of materials for the Promotion (collectively the "Promotion Entities"), (c) persons who are or purport to be immediate family members (defined as biological parent, step-mother, step-father, sister, brother, daughter, son or dependent or spouse of any of the foregoing) of any person in any of the preceding categories, regardless of where they live, or who reside in the same household (i.e., who have lived in the same household for at least three (3) of the twelve (12) months preceding the start of the Promotion Period, whether related or not) as any person in any of the preceding categories, and (d) Corporate Customers.
3. **HOW TO ENTER/ PARTICIPATE:** You participate by simply using 500 and over rollover minutes.
4. **PRIZES**
There will be ten (10) winners for the Promotion. Eight winners would each receive one Samsung Android Galaxy Y Smartphone and two winners would each receive one Samsung Tablet.

Disputes regarding rollover promotion entries: In the event of a dispute as to who made calls using rollover minutes, the 'entry' will be deemed to have been submitted by the Authorized Account Holder of the mobile phone number that submitted the request. "Authorized Account Holder" is defined as the natural person who is assigned to the relevant mobile phone account by the wireless provider, telecommunications carrier or other organization responsible for assigning mobile phone numbers for the submitted mobile number. Selected entrants may be required to provide TSTT/bmobile with proof that he/she is the Authorized Account Holder of the mobile number associated with the selected entry.
3. TSTT/bmobile reserves the right in its sole and absolute discretion to cancel, modify or suspend this Promotion at any time, if fraud, technical failures, including any network server or hardware failure, viruses, bugs, errors in programming, or any other errors or other causes beyond the control of Sponsors corrupt the administration, security, integrity or proper play of the Promotion.
4. TSTT/bmobile does not warrant that access to or use of the bMobile service will be uninterrupted or free of any of the events stated below, due to the nature of computer and wireless communications. Sponsors and the Promotion Entities are not responsible for any problems that may arise, including but not limited to; (a) lost, interrupted, inaccessible or unavailable networks, or other connection, availability or accessibility problems arising in connection with or over the course of the Promotion; or (b) communications failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions or hardware or software malfunctions, failures or difficulties; or (c) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other error in the offering or announcement of any prize or in any prize notification documents; or (d) for any errors of any kind in connection with the Promotion, whether human, mechanical, clerical, electronic, or technical in nature; or (e) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Promotion.

In no event will bmobile be liable for more than the stated number of prizes available in the prize category in question.

Actual prize(s) may vary from the prize(s) pictured. In the event of any conflict with any promotion details contained in these Official Rules and Promotion details contained in point of sale, television and print, advertising, promotional packaging and other promotion media, (Promotion Materials) the details of the Promotion set forth in these Official Rules shall prevail. The approximate retail values (ARV) of prizes as stated by the bmobile in Promotion Materials, and/or in these Official Rules are subject to price fluctuations in the consumer marketplace.
